Pursuant to the SC Guidance and Section 327(2) of the Companies Act 2016, the Chairman shall be present at the main venue of the EGM to chair the EGM. Shareholders will **NOT** be physically present at the broadcast venue on the day of the EGM. However, <u>shareholders shall</u> register their attendance at the EGM remotely by using the Remote Participation and Voting ("RPV") Facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at <u>https://tiih.online</u>.

A shareholder who has appointed a proxy or authorized representative to attend, participate, speak and vote at this EGM via RPV must request his/her proxy to register himself/herself for RPV at TIIH Online website at <u>https://tiih.online</u> in accordance with the procedures as set out in <u>the Administrative Guide latest by Monday, 1 June 2020 at 11.30 a.m.</u>
