Pursuant to the SC Guidance and Section 327(2) of the Companies Act 2016, the Chairman shall be present at the main venue of the AGM to chair the AGM. Shareholders will **NOT** be physically present at the broadcast venue on the day of the AGM. However, shareholders shall register their attendance to the AGM remotely by using the Remote Participation and Voting ("RPV") Facilities provided by Propoll Solutions Sdn Bhd, the poll facilitator via its website at www.propollsolutions.com.my ("Propoll Portal") (Domain registration number D1A403203).

A shareholder who has appointed a proxy or authorized representative to attend, participate, speak (including posing questions to the Board via real time submission of typed texts) and vote at this AGM via RPV must request his/her proxy to register himself/herself for RPV at Propoll Portal in accordance with the procedures as set out in in the Administrative Guide latest by Tuesday, 6 December 2022, at 11.00 a.m.
